PROPOSAL DEADLINES/APPLICATION PROCESS

HMIN requires that our online application be complete in its entirety and an attached W-9 form submitted. Proposals are considered four times a year by the Honda Manufacturing of Indiana (HMIN) Community Engagement Committee (CEC). Deadlines for submitting proposals for consideration at the next regularly scheduled meeting of the CEC are March 15 (for spring meeting), June 15 (for summer meeting), September 15 (for fall meeting) and December 15 (for winter meeting).

This allows the HMIN team to hold meetings, ask questions, request for additional documents etc. prior to presenting the proposal to the committee. Proposals are due the next business day if a deadline falls on a weekend.

The HMIN CEC, which meets four times per year, has announced deadlines and meetings for the remainder of 2015 and 2016.

Fall Meeting 2015

Proposal Deadline: September 15, 2015 CEC Meeting: November 20, 2015 Grant Term: January 1 – January 1

Winter Meeting 2016

Proposal Deadline: December 15, 2015 CEC Meeting: February 18, 2016 Grant Term: April 1 – April 1

Spring Meeting 2016

Proposal Deadline: March 15, 2016 CEC Meeting: May 19, 2015 Grant Term: July 1 – July 1

Summer Meeting 2016

Proposal Deadline: June 15, 2016 CEC Meeting: August 18, 2016 Grant Term: October 1 – October 1

Fall Meeting 2016

Proposal Deadline: September 15, 2016 CEC Meeting: November 17, 2016 Grant Term: January 1 – January 1

In future years, deadlines will remain the same although dates of the CEC meetings will vary. Applicants will be notified in writing concerning a decision within one month after the meeting unless otherwise informed.

- Are the objectives measureable?
